

PROTECTION GUIDE

ACTIVE MILITARY DUTY

Ticketholder, a companion, or an immediate family member, who are on active military duty, having their personal time off status changed



AUTOMOBILE THEFT

Theft of Ticketholder's automobile within 48 hours of the Event that results in inability to attend the Event



COMPLICATIONS OF PREGNANCY

Ticketholder or their companion have been advised by a physician, due to complications of pregnancy, to not attend the Event



FAMILY MEMBER OR COMPANION DEATH

The death of a family member or companion within 30 days prior to the Event



FAMILY MEMBER'S CHILDBIRTH

Ticketholder will be attending an immediate family member's childbirth at the time the Event



HOME UNINHABITABLE

Fire, Flood, Burglary, Vandalism or Natural Disaster causes home to be Uninhabitable



INJURY/ILLNESS FAMILY MEMBER

Serious Injury or Illness occurring to Ticketholder's Immediate Family Member



INJURY/ILLNESS TO YOU OR COMPANION

Serious Injury or Illness occurring to You or a Companion (including but not limited to testing positive for COVID)



JURY DUTY

Ticketholder is required to appear in court for Jury Duty, Subpoena or Court Order



LAYOFFS

Job Layoff for Ticketholder or Companion



MECHANICAL BREAKDOWN

Ticketholder or a companion's automobile having a Mechanical Breakdown within 48 hours of the Event



RELOCATION

Relocation required of You or Spouse more than 100 miles from primary residence



STOLEN TICKETS

Ticketholder or a Companion's tickets being stolen



TRAFFIC ACCIDENT

Ticketholder or a companion being directly involved in a traffic accident within 48 hours of the Event



TRAFFIC ACCIDENT ON THE WAY TO TRAVEL CARRIER

Ticketholder, a companion, or an immediate family member miss the Event due to a traffic accident enroute to a travel carrier



TRAVEL CARRIER DELAY

Ticketholder or a companion not arriving at the venue due to a delay by the travel carrier used for transportation



UNFORESEEN SEVERE WEATHER

Severe weather conditions which result in Ticketholder's inability to attend the Event



URGENT HOME REPAIR

Urgent Home Repair that requires Ticketholder to be present during the repair



WEATHER EMERGENCY

Weather Emergency within 24 hours of the Event



WORK-RELATED TRAVEL CONFLICT

Work-related Travel Conflict



TICKETHOLDER DEATH

Ticketholder's death prior to the Event
